

NOTICE OF PUBLIC HEARING  
RELATIVE TO APPLICATION  
BY THE TOWN OF SPARTA  
FOR FUNDING UNDER THE HOUSING AND COMMUNITY  
DEVELOPMENT ACT OF 1974, AS AMENDED

Notice is hereby given that the Town of Sparta will conduct a public hearing on October 6, 2020 at 7:00 PM, or as soon thereafter as the agenda will allow, at the Sparta Town Hall relative to the intention of the Town to apply for FY2020 CDBG funding under Title I of the Housing and Community Development Act.

The Town of Sparta intends to submit an application for a grant of approximately \$1,571,700 in CDBG Infrastructure funds to replace approximately 850lf of 15” and 350 lf of 8” gravity sewer line located along Bledsoe Creek, including the relocation of 400 lf of the 15” line out of the floodplain, 11 new manholes, two directional bores, and asphalt repair to Southside Drive.

The following is a tentative list of proposed activities and an estimated budget. The final application will be reviewed at the public hearing.

The proposed project will provide benefits to the entire Town of Sparta , 61.26% of whom are low- and moderate-income individuals based on US Census data. No individuals will be displaced nor will any require temporary relocation assistance as a result of the proposed project.

Citizens will be given the opportunity to provide oral and written comment on the Town’s past and proposed use of CDBG funds at the public hearing. All interested citizens are encouraged to attend.
